# President's Report



The New Zealand-bred thoroughbred has continued to succeed at the highest level during the past year winning Group One races in all our major markets culminating with an unbelievably successful 2016 Autumn Carnival in Sydney.

These successes have attracted the strongest possible buying bench to New Zealand Bloodstock's Yearling

Sales and to the recent Broodmare and Weanling Sale held at Karaka in early May.

The buoyant Sales Series have given New Zealand breeders the best results they have seen for some years. The strong support for our market from China and Inner Mongolia generated well-deserved returns to many breeders from both the sale ring and private sales.

It is hoped that these returns will be reinvested upgrading broodmares and an increased number of new stallions. Only five new stallions had been announced for the 2016/17 breeding season when the Stallion Register was closed off.

#### **FINANCE**

It is pleasing to report a turnaround in the financial fortunes of your Association.

After reporting substantial losses for the last two years the Association has made a surplus of \$13,870.

This was achieved in a number of ways:

- Negotiating with NZTR a fixed broodmare and stallion levy of \$67,000 per annum for future years.
- Increasing the subscription for the first time in eight years from \$165 to \$195 (GST inclusive) which increased subscription income by \$19,140.
- An increase in the Pearl Series Management fee to \$36,000 per annum.
- The addition of a new Commercial Partner.

Expenses have been held to a minimum, down \$29,417 on 2015, especially in personnel costs where we had a double up of salary for a period during the change in Office Managers last financial year.

Administration expenses were higher with the conversion of the financials to Xero, and Representation was higher with our CEO attending the International Breeders' Conference in Ireland last year.

We are budgeting for a small surplus in 2017.

The continued support from our loyal commercial partners,

Dunstan Nutrition, Fertco, Bank of New Zealand, Magnum Industries, Goldpine and Braithwaite & Pearks is much appreciated and recognised by members. We welcome aboard NZ Forex as a new partner and encourage members to utilise their services.

#### MEMBERSHIP AND BRANCHES

My thanks once again are extended to our branch committee members who have contributed so much worthwhile effort towards keeping their regional branches alive and well. As the hosts of many events during the year, our branches play a vital role in the education and involvement of younger breeders and the support for all breeders operating in a challenging environment.

During the past year, we have seen some members resign from the Association as their involvement in thoroughbred breeding comes to an end, but on a positive note, we have received more new members signing up to the Association than in the previous year. The future of our Association lies in the strength of our branch membership and I thank everyone who has accepted a position on their local branch committee.

#### **BLOODSTOCK TAX ISSUES**

Significant time and effort has been committed to providing greater certainty and clarity about a number of tax issues that have been the subject of litigation during the last few years.

The discussions have taken a giant step forward over the year by the NZTBA and the NZ Racing Board joining together in their discussions and submissions with the IRD. The Association is extremely grateful that the New Zealand Racing Board's CEO, John Allen, has taken on these issues as a personal crusade, and has enlisted the support of a Senior Partner of Chapman Tripp, David Patterson, to provide more detail and justification to our extensive submissions.

Together with the assistance of John Aubrey, Rob Braithwaite of Braithwaite & Pearks Ltd, Michael Martin and myself, it has been a formidable team of tax and bloodstock knowledge that has made significant progress. The process is near its end, and if there are still issues we disagree with IRD, these will be pursued with the Ministers of Racing and Revenue with valuable support from the New Zealand Racing Board.

#### HEALTH AND SAFETY

The new Health and Safety at Work Act 2016 became law in New Zealand on 4 April 2016. The Association has been represented at excellent meetings around the country organised by New Zealand Thoroughbred Racing to educate and inform industry stakeholders about their responsibilities under the new Act including, Guides to Managing Risk around horses, Staff and Contractor Induction, and the



Safer Farms Toolkit. An extensive library of information and helpful advice is available on the NZTBA website and additional assistance can be sought through our Cambridge office if required.

#### NEW ZEALAND THOROUGHBRED MARKETING

The Council is currently represented on the NZTM Board by John Thompson, and the Studmaster Branch by Jo Griffin and Rodney Schick. I thank them, as well as Chairman Chris Weaver, Andrew Birch CEO, and Tara Hughes for their considerable efforts and success in the promotion of the New Zealand thoroughbred to the world.

Last year I reported that the NZTBA was planning to upgrade its website in conjunction with NZTM in a design that incorporated "all things thoroughbred". The delays to this project have been very frustrating to us and I am still unable to report to members that the new website is up and running. It is hoped that this important communication centre for our Association can be completed without further delays.

A communication centre that has been a great success for NZTM is the NZ Racing Desk. With anchor man Paul Vettise heading up a strong team of contributors, the NZ Racing Desk plays a vital role in disseminating news and photos of the New Zealand Thoroughbred racing and breeding industry to newspapers and electronic publications throughout the world. Congratulations to both NZTM and NZTR who fund this highly successful initiative. It provides copy seven days a week and has lifted our industry's profile, both locally and internationally.

Outside our mature markets of Australia, Hong Kong and Singapore, NZTM, ably assisted by NZ Bloodstock, has also nurtured the growing level of investment activity from mainland China.

#### EQUINE HEALTH ASSOCIATION

The NZTBA continues to be represented on the NZ Equine Health Association (NZEHA) by our CEO Michael Martin.

The Association would like to thank Dr Ivan Bridge (Chairman), Dr Patricia Pearce (Executive Advisor) and Simon Cooper (NZTR) for their oversight of a large number of issues associated with Equine Health in New Zealand. One such issue during this past year has been the consultation on the proposed animal welfare regulations designed to improve the already strong requirements we have around animal welfare in New Zealand. Matters covered in these consultations include, live animal exports, care and conduct towards animals, and surgical and painful procedures. A number of these regulations target the welfare of horses. Members need to be aware of increased public scrutiny of all aspects of equine welfare in New Zealand.

During the past year the NZEHA supported a pilot initiative to deliver training to a group of Chinese equine practitioners.

This invitation offered the Chinese visitors access to New Zealand technical veterinary expertise as a means of ensuring quality care for the growing number of New Zealand horses exported to China. The Ministry of Primary Industries (MPI) assisted with expenses, as did Dr Jonathan Hope of Cambridge by raising generous business sponsorship.

The NZTBA also acknowledges the outstanding work of the New Zealand Equine Research Foundation (NZERF) which has been supporting research undertaken in New Zealand for over 40 years, and since 1980 has funded more than 80 projects. Our Association is represented on the NZERF board by Michael Martin who assists in the selection of worthy research projects supported by stakeholders involved in the wider New Zealand equine industry.

#### **EDUCATION**

If the breeding sector is to continue to attract skilled young horsemen and horsewomen there must be clear pathways offering good conditions and opportunities for learning and personal development.

It is nearly four years now since the Primary Industry Training Organisation (PITO) took over the responsibility for Equine Training, including stud & stable hands, harness drivers & apprentice jockeys. While progress has been slow, working together has been constructive for all sectors. Students report that the lectures and information are of a high standard, offering them excellent learning opportunities.

Our thanks to Lisa Dunbar, who is employed by NZTR, for taking the classroom syllabus to venues outside the Waikato, enabling students to complete their assignments alongside their daily responsibilities on the studs.

Brad Reid, the recently appointed CEO of the Standardbred Breeders' Association, is currently developing a breeders' course in the South Island which will be available to Thoroughbred breeding students as well. While there may be slightly different on-farm work, the theory is similar for all breeding horses. It is hoped that Standardbred students will join some of the North Island courses in the future.

While student numbers enrolled with the Waikato-based course remain fairly static at approximately 16 students, there are opportunities for some units of the breeding course to be completed as part of secondary school NCEA qualifications. This can be a valuable introduction to the breeding industry at a time when school leavers are considering different career options, especially for young people who may not be from families already involved with horses.

#### NZTBA EDUCATIONAL SCHOLARSHIPS

Benji King, who was awarded the 2015 Sunline International Management Scholarship, returned home to New Zealand in October 2015. He brought back the valuable experience gained from eight months overseas to his family's stud farm, Brighthill Farm in the Waikato, as did Dylan Treweek, who returned from the Irish National Stud course to his family's Lyndhurst Farm.

Once again this past year, we had a great group of applicants for both the Irish National Stud Scholarship and the International Management Scholarship. The two outstanding recipients for our 2016 scholarships are currently taking up the opportunity.

The 2016 Sunline International Management Scholarship was awarded to 27 year old Bevan Smith. After graduating with a Commerce degree, Bevan expanded his thoroughbred knowledge working on various stud farms and racing stables in both Australia and New Zealand before joining New Zealand Bloodstock where he worked in a marketing role and in the company's website auction arm, Gavelhouse.

The Irish National Stud scholarship is very generously supported by the Keith & Faith Taylor Equine Scholarship. This year's winner was 23 year old Hannah Mee. Hannah has worked on thoroughbred studs both in Australia and New Zealand including five seasons at Cambridge Stud.

I encourage all members to visit our website and read both Bevan and Hannah's Blogs – they give an excellent insight to the opportunity these Scholarships continue to provide to the fortunate young recipients.

#### ACC LEVIES

It is disappointing to report that even after joint submissions by NZTR, NZTBA and NZTA the Government decided to increase ACC levies for our industry from 1 April 2016.

Levies for breeders and agistment farms have increased by 10% (slightly below 2013/14 levels) and trainers and jockeys by 22% (slightly above 2013/14 levels).

The thoroughbred sector, with NZTR's support, has now joined with a team from ACC to investigate targeted strategies to reduce the industry's injuries and reduce future ACC levy rates. ACC officials have visited both stables and stud farms to investigate injury prevention initiatives.

The levy increases for the thoroughbred industry are due to the flow-on effects from the cessation of the residual levy from 1 April 2016. Our industry has been caught as one of the levy-payers who need to continue to collect this levy every year to fund the estimated cost of accidents into the future.

The ACC does appreciate that the increases must be disappointing to stakeholders given the substantial investment that the thoroughbred industry has made in recent years towards injury prevention and general safety.

#### NZB INSURANCE PEARL SERIES

The Pearl Series continues to be a valuable initiative for owners of fillies and mares racing in New Zealand to retain and race their fillies and attract potential new owners. Now in its fourth year, the Series has clearly been a success story with trainers and owners targeting the many Pearl races that are programmed throughout New Zealand.

Congratulations to each and every winning owner who has enjoyed their filly's success. Bonuses are paid through NZTR's Owners' Settlement account and again I wish to record my appreciation to NZTR for their assistance in this regard. The many winners have reported that the Bonus payment has made a very big difference in making their racing year a success.

Early Bird enrolments for the 2016 Series closed on 28th February 2016 with 420 fillies enrolled. Entries will still be taken for the 2016 Series up until 31st July with an entry fee of \$920 inc. GST.

One issue that has arisen is race club reluctance to programme enough races, both beyond maidens, and further than 1600m for fillies and mares only. We encourage our members who are connected to racing clubs to urgently discuss this issue with their Committees as, in my opinion, it is preventing the Series reaching its full potential and return for all stakeholders including the clubs.

My grateful thanks to New Zealand Bloodstock Insurance for their continued support in sponsoring the Series, and to Michael Martin, Nicola Griffiths and Vicki Pascoe for their management and promotion of the Pearl Series.

#### **COUNCIL AND STAFF**

I wish to thank Council members for their support and input to the Association this year. We have not met as much as in past years in an endeavour to keep costs down, but there has been plenty of behind the scenes input from all members, especially the Executive Team.

I particularly wish to thank Vicki Pascoe for the time and effort she has put into the Education portfolio which has had a number of difficult issues that have frustrated her this year.

My appreciation is extended to our CEO Michael Martin who has served the Council and its members in his usual committed manner again this year. He has also visited a number of our Branches during the year to discuss ideas of improving the Association's value and relevance for members.

Also thanks to our Office Manager Nicola Griffiths for her input in what has been a challenging year, especially when the CEO and Office Manager operate in different locations for a large part of the week.

We are still committed to our offices being based in Cambridge, close to the industry. Our goal is to have a centre for the horse in Cambridge, which would have the NZTBA, Owners Federation, Arion Pedigrees and NZTM in one location along with other equine Associations that may be interested.

#### INDEPENDENT AUDITOR'S REPORT

#### To the Members of the New Zealand Thoroughbred Breeders' Association (Inc.)

We have audited the financial statements of the New Zealand Thoroughbred Breeders' Association (Inc.) on pages 6 to 10, which comprise the statement of financial position as at 31 March 2016, the statement of financial performance and the statement of movements in equity for the year then ended, and a summary of significant accounting policies and other explanatory information.

#### Council's responsibilities for the Financial Statements

## Notes to the Accounts

#### FOR THE YEAR ENDED 31 MARCH 2016

#### NOTE 1: STATEMENT OF ACCOUNTING POLICIES

#### 1.1 Statement of Accounting Policies

The entity reporting is New Zealand Thoroughbred Breeders' Association (Inc.) (NZTBA), which is registered under the Incorporated Societies Act (1908). The accounts have been prepared in accordance with NZ GAAP.

#### 1.2 General Accounting Policies

1.3

The measurement base adopted is that of historical cost.

#### Particular Accounting Policies

#### ACCOUNTS RECEIVABLE

Accounts receivable are stated at expected realisable value. Provision has been made for bad debts where considered necessary.

#### FIXED ASSETS AND DEPRECIATION

Fixed Assets are recorded at cost and with the exception of the Library, have been depreciated at maximum rates allowable by the Inland Revenue Department for taxation purposes. These rates are considered appropriate for the purposes of these financial statements. The Library is not depreciated. Depreciation rates used are shown below:

Fixtures & Fittings	20% DV
Office Equipment	33% - 48% DV

#### INCOME TAX

The Association adopts the taxes payable method of accounting for income tax.

The income tax expense for the period is equal to the income tax payable for the same period. The income tax effects of timing differences are not recognised.

Income and expenditure directly attributable to the membership of the Association is non-assessable for taxation purposes.

Income tax benefits arising from income tax losses are only recognised where there is virtual certainty of their realisation.

#### **OPERATING LEASES**

Operating lease rentals are recognised evenly over the expected period of benefit to the Association.

#### SUBSCRIPTION REVENUE

The subscription year runs from 1 April to 31 March. Income from subscriptions is taken up on a cash received basis. GST

GST is accounted for on a payment basis. Revenue and expenses are shown net of GST.

#### DIFFERENTIAL REPORTING

The Association has applied various differential reporting exemptions under the "Framework for Differential Reporting" as allowed by the New Zealand Institute of Chartered Accountants.

There are two criteria that establish the Association as a qualifying entity for differential reporting. Firstly the Association is not publicly accountable and the Association does not have the coercive power to tax, rate or levy to obtain public funds. Secondly the Association is not large as its total revenue does not exceed \$5 million and it has fewer than 20 employees.

The Association has taken advantage of all differential reporting exemptions available to it.

#### 1.4 Changes in Accounting Policies

There have been no changes in the above accounting policies which have been applied on bases consistent with those in previous years.



#### NOTE 2: FAMIS TERM DEPOSIT

The Association's FAMIS incentive scheme was started in 1992 and finished on 31 July 2006. The residual Bonus pool held at that date was \$107,525. In 2006 the Council resolved that the residual pool be retained and applied to future racing/breeding projects. In March 2013 the Council resolved to transfer \$7525 from this fund to the new Pearl Series Bonus Scheme to assist the launch and promotion of the Series. In March 2014 the Council resolved to transfer \$10,000 from this fund to assist the Association with the moving costs associated with the abandonment of the NZTBA office at Ellerslie Racecourse. At balance date the residual fund is now \$90,000. This is secured by a corresponding amount on Term Deposit at the Bank of New Zealand, Matamata Branch. The FAMIS fund balance is not reflected in the Association's Statement of Financial Position.

#### NOTE 4: PURPOSE OF OPERATIONS

The Association operates in New Zealand within the breeding sector of the thoroughbred racing industry.

#### NOTE 5: NEW ZEALAND THOROUGHBRED MARKETING LIMITED

In 1998 New Zealand Thoroughbred Marketing Limited (NZTM) was established to take over the marketing function previously undertaken by the Association.

NZTM is three fifths owned by the Association, with the other shareholders being NZ Bloodstock Limited and NZ Thoroughbred Racing (formerly NZ Racing Conference).

The investment in this company is not paid up and represents a contingent liability to the Association of \$2 as at 31 March 2016. (2015: \$2)

Legal entitlement to the New Zealand Bloodstock Limited 0.50 percent levy from the sale of thoroughbreds in NZ is held by the Association. The Council has agreed however to pass this revenue on to NZTM to be used for marketing purposes by that company.

At year end any amounts receivable from NZ Bloodstock Limited are in turn due to NZTM under the above arrangement. They therefore have no impact on the results of the Association and have not been recognised in the Statement of Financial Position.

#### NOTE 6: CONTINGENCIES

As stated in Note 7 above, the Association has a contingent liability for its unpaid capital investment in NZ Thoroughbred Marketing Limited of \$2. There are no other contingent liabilities at 31 March 2016.
